- NAME OF PROGRAM:** BRICKLAYERS DISTRICT COUNCIL OF WV J.A.T.C.
- TO APPLY:** VISIT YOUR LOCAL WORKFORCE WEST VIRGINIA JOB SERVICE OFFICE OR WESTERN MARYLAND ONE STOP JOB CENTER
- MINIMUM QUALIFICATIONS**
- AGE:** MUST BE 18 YEARS OLD
- EDUCATION:** HIGH SCHOOL DIPLOMA OR EQUIVALENT
- PHYSICAL:** MUST BE PHYSICALLY ABLE TO PERFORM THE WORK OF THE TRADE. A DRUG TEST WILL BE REQUIRED.
- DRIVERS LICENSE:** MUST HAVE A VALID DRIVERS LICENSE
- RESIDENCY:** MUST BE A RESIDENT OF WEST VIRGINIA OR THE FOLLOWING MARYLAND COUNTIES: ALLEGANY, GARRETT & WASHINGTON OR A COUNTY OF ANOTHER STATE THAT TOUCHES A WEST VIRGINIA STATE LINE. HOWEVER, ALL WORK PERFORMED SHALL BE IN WV OR THE THREE COUNTIES IN MD.

A COPY OF YOUR BIRTH CERTIFICATE, HIGH SCHOOL TRANSCRIPT OF GRADES, HIGH DIPLOMA OR HIGH SCHOOL EQUIVALENT, AND A COPY OF YOUR VALID DRIVERS LICENSE WILL BE REQUIRED AT A LATER DATE. ONLY COPIES WILL BE ACCEPTED.
